4. First Aid Measures

- Ingestion** If swallowed, rinse mouth with water (only if the person is conscious). Obtain medical advice.
- Eye Contact** In case of contact with eyes, rinse immediately with plenty of water for at least 10 minutes and seek medical advice.
- Inhalation** If inhaled, remove person to fresh air. If not breathing give artificial respiration. If breathing is difficult, give oxygen.
- Skin Contact** After contact with skin, wash immediately affected area with soap and plenty of water. Seek medical advice if irritation persists.

5. Fire Fighting Measures

Extinguishing Media: Water spray, carbon dioxide, dry chemical powder or appropriate foam.

For safety reasons do not use full water jet. Known or Anticipated

Hazardous Products of Combustion: Emits toxic fumes under fire conditions.

Special Fire Fighting Procedures: Wear self-contained breathing apparatus and protective clothing to prevent contact with skin and eyes.

6. Accidental Release Measures

Procedures for Spill/Leak Clean-up: Cover with an inert, inorganic, non-combustible absorbent material (e.g. dry-lime, sand, soda ash).

Place in covered containers using non-sparking tools and transport outdoors. Avoid open flames or sources of ignition (e.g. pilot lights on gas hot water heater). Ventilate area and wash spill site after material pickup is complete. Dispose of in accordance with current laws and regulations.

Environmental Precautions: To avoid possible contamination of the environment, Do not discharge into any drains, surface waters or groundwaters. Personal Precautions: Wear respirator, chemical safety goggles, rubber boots and heavy rubber gloves. Keep people away, evacuate area.

7. Handling & Storage

Handling Provide suitable air extraction ventilation in the work areas. Vapours may form explosive mixtures with air.

Storage To be stored in tightly sealed and preferably full containers in cool, dry and ventilated area. Keep in glass, suitable plastic, aluminium or lacquer-lined containers.
Storage: Keep material away from sources of ignition (e.g. hot surfaces, sparks, flame and static discharges. Protect from heat/overheating and light sources.

8. Exposure Controls & Personal Protection

General Information Measures should be taken to prevent materials from being splashed into the eyes or on the skin.

Hand Protection Compatible chemical-resistant gloves are recommended. Wash contaminated gloves before reuse.

Skin Protection Avoid contact with skin.
Eye Protection Low risk in normal use.
Respiratory Avoid inhalation of very high levels or of mist.
