# 4. First Aid Measures

Measures in the event of

#### Ingestion

– Inadvertent ingestion of the impregnation medium of the wipes: carefully wipe out the mouth in order to prevent further ingestion; then offer water but do not pour in by force; do not induce vomiting; consult a doctor or a Poison Control Centre as a precautionary measure. In the event of children and adults: do not induce vomiting. Rinse out mouth and drink around one glass of water. Where appropriate, consult competent Poison Control Centre or doctor.

- Inadvertent swallowing of the wipes by young children: always call doctor immediately.

#### **Skin Contact**

- No action required

#### **Eye Contact**

- Inadvertent contact with eyes: rinse thoroughly with plenty of lukewarm water immediately; if irritation persists, consult an ophthalmologist as a precautionary measure.

#### Inhalation

- an improbable route of contact.

When consulting a doctor or a Poison Control Centre, always have packaging or label available.
