## 4. First Aid Measures

Measures in the event of

#### Ingestion

In the event of spillage/leakage: mop up main volume with cloths; when larger amounts are involved, dispose of cloths and mopping up material by controlled disposal. Remove rest with plenty of water and common cleaning agent.

Packaging can be recycled after residual emptying and rinsing.

Filled, unused packages must be disposed of separately in accordance with the waste management directives of the local area.

### 7. Handling & Storage

Must be used in accordance with manufacturer's instructions. Observe any warnings on packaging. Store in a cool and dry place (room temperature). Reseal container after use.

### 8. Physical & Chemical Properties

The product is a chemically inert personal hygiene emulsion for skincare of the hands.
